



## MILLENNIUM HALL PARKING POLICY AND GUIDELINES

### **MILLENNIUM HALL PARKING POLICY (ALL RESIDENTS)**

A valid Millennium Hall permit (issued by the Millennium Hall Management Office) must be properly displayed at all times when parked in the Millennium Hall lots. The Millennium lots are the two lanes in the front of the building and the two lanes closest to the building in the rear. Permits issued by Towson University Parking Services (commuter permits, etc.) are NOT valid in the lot and will be towed at owner's expense. In addition, parking in handicapped/reserved spaces without a Millennium Hall permit, or parking in the fire lanes will also result in the vehicle being towed at owner's expense.

### **GUEST PARKING / TEMPORARY PERMITS**

As a resident of this building, it is your responsibility to make guests aware of the Millennium Hall parking policy. As a courtesy, Millennium Hall does issue temporary parking permits for guests of residents wishing to park in the lot **after 5:00 PM, Monday through Thursday, until 9:00 AM the next day. Temporary parking permits are not issued on Fridays!** Residents are allotted four temporary parking permits per month and may only reserve one permit in a 24-hour period. A total of five temporary parking permits are issued per day. Residents may request a temporary parking permit by stopping by the Management Office, Monday through Thursday (9 AM - 5 PM). Temporary parking permits will not be issued during Homecoming, Tiger Fest, etc. During weekends, guests should be parking in West Village garage on the ground level for visitor parking. **Please do not park in the Enrollment Services lot (Lot 17).**

### **RESIDENTS WITH A MILLENNIUM HALL PARKING PERMIT**

Your permit must be displayed properly at all times when parked in the Millennium Hall lots. Millennium Hall Parking Permits must hang unobstructed from your rearview mirror, facing outward. **You will be towed even if your permit is on the dashboard, seat, or floor of the vehicle.**

The Millennium Hall Parking Permit is only valid for the Millennium Hall lots. Permits may not be passed between vehicles. Violators will have their parking privileges revoked (with no refunds) and the vehicle will be towed. Reproduction of the Millennium Hall Parking Permit is prohibited. Violators will be towed and face criminal action. **If you lose your permit, you will no longer be guaranteed a parking space** in Millennium Hall. If you are approved by Management to receive a replacement permit, you will be required to purchase a new one at full cost.

### **OBTAINING PARKING THROUGH MILLENNIUM HALL**

Since Millennium Hall's parking lot contains 145 spaces for 420 residents, priority is given to residents who renew their housing for the upcoming academic year. If any permits remain, we will begin offering to new residents based on their parking waitlist number. You must indicate you are interested in parking at the time of your online housing application to be placed on the waitlist. The cost for Millennium Hall Parking Permits will be available over the summer and will mirror the cost for a campus parking permit. Parking offers are sent to the student's email address on file. *Please note that it is unlikely that students who are new to Millennium Hall will receive a parking permit offer for their first semester.*

### **PARKING THROUGH TOWSON UNIVERSITY**

Due to the limited availability of Millennium parking spaces, Millennium Hall residents who are unable to purchase a Millennium Hall Parking Permit may be eligible to purchase a Towson University parking permit. ### **POLLARD'S TOWING**

In order to ensure that our permit holders have a parking space, Millennium Hall has a contractual agreement with Pollard's Towing to remove all non-permit holding vehicles from our lots. If you are towed for any reason, you will not receive reimbursement from Millennium Hall. Do not put yourself at risk to be towed by parking in the lot without a parking permit, or by not properly displaying your permit. Towing is enforced 24 hours a day, 7 days a week. If towed, contact Pollard's Towing directly at 410-823-1808. When towing enforcement is suspended, notices will be posted at entrances/exits, at mailboxes, and at the Main Office.
